

DECLARATION

In consideration of receiving the aforementioned dog from

Dun Roamin Re-Homing

I we/have read the recommendations and hereby undertake the following:

WITHIN THE 3 MONTH TRIAL PERIOD (* DENOTES THAT PROOF WILL BE REQUIRED)

REGISTER THE DOG WITH A VET*

HAVE THE DOGS CONDITION/HEALTH CHECKED BY THE VET
(THIS IS FREE IF YOU REGISTER WITHIN 7 DAYS OF ADOPTION WITH EITHER RIVERSMEET OR MARMION VETS IN TAMWORTH)

NEUTER THE DOG IF CONFIRMED BY THE VET THAT HE/SHE ISN'T ALREADY*

COMMENCE FLEA AND WORMING TREATMENT

ENSURE THAT UP TO DATE CONTACT DETAILS SUCH AS MY NAME, ADDRESS, TELEPHONE NUMBER ETC. ARE PERMANENTLY ATTACHED TO THE DOG IN ADDITION TO THE TAG SUPPLIED*

INFORM DUN-ROAMIN OF ANY BEHAVIOURAL PROBLEMS THAT MAY MAKE THE DOG UNSUITABLE AND RETURN THE DOG TO THEM WITHIN 3 MONTHS OF THE DATE OF THIS AGREEMENT. I UNDERSTAND THAT DOGS RETURNED AFTER THIS TIME WILL BE SUBJECT TO THE SAME COSTS AND PROCEDURES AS ANY OTHER DOG OFFERED TO DUN-ROAMIN FOR REHOMING PURPOSES

INFORM DUN-ROAMIN OF ANY NON-STANDARD VETERINARY TREATMENT THAT THE DOG MAY REQUIRE DURING THIS PERIOD AND ENSURE THAT THIS TREATMENT IS SOUGHT IMMEDIATELY

PERMIT AN OCCASIONAL VISIT FROM A DUN-ROAMIN OPERATIVE TO ENSURE THAT THE DOG IS HAPPILY SETTLED AND/OR TO ALLOW THEM TO REPOSSESS THE DOG, IF IN THEIR OPINION THE TERMS OF THIS AGREEMENT ARE BEING BREACHED. FAILURE TO ALLOW THE MANDATORY VISIT PRIOR TO THE DOG BEING SIGNED OVER PERMANENTLY WILL RESULT IN THE DOG BEING REPORTED STOLEN BOTH TO THE POLICE AND ON THE MICROCHIP DATABASE

ALLOW DUN-ROAMIN TO EXTEND THE 3 MONTH TRIAL PERIOD AS THEY SEE FIT. NOTICE WILL BE GIVEN VERBALLY WITH WRITTEN CONFIRMATION FOLLOWING ON STATING THE REVISED TRIAL PERIOD AND THE REASONS FOR THIS EXTENSION

AT ALL TIMES

EXERCISE THE DOG REGULARLY

FEED, WATER & HOUSE THE DOG IN AN APPROPRIATE MANNER

NOT TO USE ANY FORM OF CHOKER CHAIN ON THE ANIMAL

NOT TO CHAIN THE DOG OR LEAVE THE DOG ALONE FOR AN UNREASONABLE PERIOD OF TIME

NOTIFY US IN WRITING SHOULD YOU CHOOSE TO HAND OVER OWNERSHIP OF THE DOG IN THE FUTURE

MAINTAIN REGULAR CHECK-UPS AT THE VETS AND TO CONTINUE WITH VACCINATIONS, FLEA TREATMENT AND WORMING

Dun Roamin Stray Dog Collection & Animal Services & it's representatives shall not be held responsible for injury or damage caused either directly or indirectly by the animal. For the purposes of common or statute law, the adopter shall be deemed the owner of the dog.
